#### Mayor and Council Comments:

Mayor and Council congratulated Marcella Aylwin on her promotion to Provisional Police Chief. Councilwoman Heist stated the dedication of the "Expression Swings" in Rotary Park in memory of Jon Senn was held on October 11, 2021. Councilman Dash expressed his concerns with regulating "Short Term Rentals". Councilman Trythall expressed concerns over the promotion of Marcella Aylwin to Provisional Police Chief. Trythall felt Aylwin should have been promoted to Lieutenant.

Public Comment: Mike Jiampetti, 208 New Orleans was upset with Council for not expressing there concerns with promoting Aylwin prior to a Council meeting. Stefania Kuehner, Chicago Avenue expressed her displeasure in the behavior of Council members. Ms. Kuehner stated the behavior is very unprofessional and embarrassing. Nanette Galloway, Buffalo Avenue congratulated Chief Alywin. Ms. Galloway spoke on Landing Creek off Clarks Landing Road and the newly installed trash cans. Ms. Galloway stated the tree at City Hall will be rep-laced next week. Ms Galloway stated there will be a new walkway installed in Peace Pilgrim Park. Ms. Gallowat asked for the status of the tree ordinance she requested. Heist asked her to forward the information to Councilwoman Brown who is the Chair of The Ordinance Committee.
