November 18, 2021

The Remote and in Person Regular Meeting of Common Council of Egg Harbor City was held on Thursday, November 18, 2021 at 7:00pm with Mayor Lisa Jiampetti present. Council President Ricci opened the meeting and the following members of Council were present: Mattia Brown, Ingrid Nieves-Clark, Steve Dash, Robin Sefton, Karl Timbers, Scott Trythall and Mason Wright.(Donna Heist not present)

Council President Ricci called the meeting to order and made the following announcement:

Council President Ricci also stated due to the Covid-19 Pandemic and social distancing requirements, the meeting is being conducted via Zoom, conference call and in person. Council President Ricci asked if anyone from the public had any comment on any item on the agenda and there was no comment from the Public.

Mayor's Presentation: Mayor Jiampetti the EHC Citizenship Award Ms. Byrd. Mayor Jiampetti gave the Oath of Office to Zachary E. Perna as Egg Harbor City Lieutenant.

Mayor Report: Mayor Jiampetti stated the City spoke about the grant the City received for the 100 and 200 block of Washington Avenue. Mayor Jiampetti spoke on the EHC Bike Path progress and the upgrades to the EHC Lake Bridge. Mayor Jiampetti stated the EHC Christmas Tree Lighting will be held on December 4th at 6pm and the EHC Christmas Parade will be on December 18th at 6pm.

Councilman Timbers gave an update on EHC Land Use Board and Eyren Hafen. Councilwoman Brown stated she would like to set up a Ordinance Committee meeting to discuss parking on side streets. There was discussion over the Safety Committee looking into the parking on side streets in EHC and the safety issues it causes, after discussion and deliberation it was decided which ever committee handles the issue of side street parking, the Chief of Police should attend the meetings. Council Pres. Ricci stated fill is

needed at St. Louis and WHP, and the Superintendent of Public Works, Keith Adams stated he will take care of following up with this issue. Council Pres. Ricci asked if the City had control over the lot in the Industrial Park and the City Engineer stated the City is working on getting control. Councilwoman Clark asked for the status on the additional signage around to be installed around Spragg School, and was told by the CFO, Jodi Kahn that the signs are on order. Councilwoman Brown asked for an update on the signage for the handicap child in the area where she lives. Chief Alywin said the police department is looking into this request.

Chief of Police Report: Chief of Police Marcell Aylwin gave an update on the EHCPD. CFO Report: CFO Jodi Kahn went over her quarterly report.
