April 11, 2024

The Remote and in Person Regular Meeting of Common Council of Egg Harbor City was held on Thursday, April 11, 2024 at 7:00pm with Mayor Lisa Jiampetti present. Council President Ricci opened the meeting and the following members of Council were present: Kasey Attianese, Ingrid Nieves-Clark, Steve Dash, Nanette Galloway, Donna Heist, Kim Hesse, Karl Timbers and Mason Wright.

Council Pres. Ricci called the meeting to order and made the following announcement: In compliance with the "Open Public Meetings Act" of the State of New Jersey, adequate notice of this meeting of the Egg Harbor City Common Council was provided in the following manner:

- 1. Advance written notice of this meeting was posted on the Egg Harbor City Hall Bulletin Board.
- 2. Advance written notice of this meeting was posted on the Egg Harbor City website.
- 3. Advance written notice of this meeting was sent to the Hammonton Gazette and the AC Press.

Council President Ricci stated the meeting is being conducted via Zoom, conference call and in person. The meeting is also being recorded to air on the Egg Harbor City website, Channel 97 and Facebook.

Council Pres. Ricci asked if there was any comment from the public on any agenda item, and there was no comment. Ben Risley, 2058 Liverpool Avenue came before Mayor and Council. Mr. Risley expressed his concerns with the Non-Profit Tax Exemptions on the agenda. Council Pres. Ricci explained that they have met the criteria for Tax Exemption with the Assessor. Mr. Risley stated the City should be making sure the properties that are given tax exemptions for their use are permitted uses in the zones. Council Pres. Ricci stated the City is looking into the tax exemption concerns.

Upon motion of Wright, seconded by Hesse and carried, the March 14, 2024 Council meeting minutes were approved.

Mayors Report: Mayor Jiampetti stated the City Engineer Ryan McGowan and her met with the NJDEP. Mayor Jiampetti gave an update on upcoming events in the City. Mayor Jiampetti stated the Mayors Wellness Walk will be on April 21st and the City Wide Clean Up is May 4th.

Committee Chair Reports: Council Pres. Ricci gave an update on the Redevelopment Committee and the Building and Code Enforcement Committee. Specifically speaking on 111 New York Avenue, a dilapidated church on Philadelphia Avenue near Moss Mill Road and the demolition of Weisbecker's Cleaners. Council Pres. Ricci stated the City is looking into have the Department of Public Works cut the grass on properties in violation. Mayor Jiampetti questioned whether it would be cost effective to have public works cut grass for properties in violation. Councilwoman Heist gave an update on DPW. Councilwoman Attianese gave an update on Parks and Playgrounds. Attianese stated the Campground Manager has not submitted the required 2024 Capital Improvement Plan for the campground. Council Pres. Ricci asked the City Attorney to send a letter to the Campground Manager stating they are in violation of the agreement. Councilman Timbers gave an update on the EHC Land Use board. City Clerk Meg Steeb stated there will be an orientation meeting for the 2024 lake staff on May 8, 2024 at 6:00pm. Ms. Steeb stated a representative from Statewide will be there to give safety training to the 2024 lake staff. Councilwoman Hesse stated the Sam Weiner Easter Egg

Hunt was a success, and thanked EHC Police Officers Thomas White and Darryl Fonville for their participation. Councilwoman Galloway gave an update on Sustainable EHC.
