September 19, 2024

The Remote and in Person Regular Meeting of Common Council of Egg Harbor City was held on Thursday, September 19, 2024 at 7:00pm with Mayor Lisa Jiampetti present. Council President Ricci opened the meeting and the following members of Council were present: Kasey Attianese, Ingrid Clark, Steve Dash, Nanette Galloway, Donna Heist, Kim Hesse, and Mason Wright.(Karl Timbers was not present)

Council Pres. Ricci called the meeting to order and made the following announcement: In compliance with the "Open Public Meetings Act" of the State of New Jersey, adequate notice of this meeting of the Egg Harbor City Common Council was provided in the following manner:
