The Remote and in Person Regular Meeting of Common Council of Egg Harbor City was held on Thursday, May 9, 2024 at 7:00pm with Mayor Lisa Jiampetti present. Council Pro Temp Donna Heist opened the meeting and the following members of Council were present: Ingrid Nieves-Clark, Donna Heist, Kim Hesse, and Karl Timbers and Wright.(Not present were Kasey Attianese, Steve Dash, Nanette Galloway, Joseph Ricci)

Council Pro Temp Heist called the meeting to order and made the following announcement:
