### April 7, 2022

The Remote and in Person Regular Meeting of Common Council of Egg Harbor City was held on Thursday, April 7, 2022 2022 at 7:00pm with Mayor Lisa Jiampetti present. Council President Ricci opened the meeting and the following members of Council were present: Steve Dash, Donna Heist, Kim Hesse, Robin Sefton, Karl Timbers, Scott Trythall and Mason Wright.(Not present Mattia Brown)

Council President Ricci called the meeting to order and made the following announcement:

In compliance with the "Open Public Meetings Act" of the State of New Jersey, adequate notice of this meeting of the Egg Harbor City Common Council was provided in the following manner:

- 1. Advance written notice of this meeting was posted on the Egg Harbor City Hall Bulletin Board.

Council President Ricci also stated due to the Covid-19 Pandemic and social distancing requirements, the meeting is being conducted via Zoom, conference call and in person. The meeting is also being recorded to air on the Egg Harbor City website ad Channel 97.

Upon motion of Wright, seconded by Timbers and carried, the March 24, 2022 Council meeting minutes were approved.

Council Pres. Ricci asked if there was any comment from the public on anything on the agenda and there was no comment.

Dominic Brankin and Jim Casis of EHT urged Mayor and Council to consider supporting the resolution on the agenda regarding "Expressing Opposition to any Legislation that Infringes Upon an Individual's Second Amendment Rights". Presentation: Steve Fiedler, the Coordinator of Friends Along the Mullica Project and Chairman of the Galloway Township Environmental Commission presented the "Collaboration Award" to Mayor Lisa Jiampetti. Mr. Fiedler recognized EHC residents Richard Colby, Rick Dovey and Hazel Muller who are active in protecting and preserving the Mullica River Watershed.

Mayor Jiampetti stated the city currently has approximately 744 rental units, and should not be encouraging people to rent their properties. Mayor

Jiampetti stated she has spoken to Mayors of other municipalities who have similar ordinance on their books, and they are not happy with the ordinance. Mayor Jiampetti stated the ordinance would cause a burden to the EHC Police and Code Enforcement Departments. Mayor Jiampetti stated the "Short Term Rentals" should not be regulated, the City can ban "Short Term Rentals" in the City. Hesse and Dash spoke out against the ordinance as written.
